1. All exits clearly identified & emergency lighting available				
2. Schematic drawing of exit plans posted in each room (north at the top & locations of fire extinguishers				
3. Current inspection of fire extinguishers Date:				
4. Extinguishers in proper locations & staff trained in use				
5. Fire extinguishers are checked monthly				
6. Smoke detectors & other alarms are checked monthly				
7. Consideration is given to the evacuation of children/adults with special needs (ask staff).				
8. Emergency procedure is established, posted, & practiced. <ul style="list-style-type: none"> • Fire Drills are practiced monthly • Tornado Drills (Sept/Oct & April/May) 				
9. Emergency Preparedness Log is posted & completed.				
10. Procedures for action in case of medical emergency				
11. First-aid information available to include choking				
12. Basic CPR instructions available				
13. Dental emergency chart				
14. Accurate emergency cards containing current medical & dental provider & persons to contact accessible but not for public view

1. Appropriate space per child - 35 sq. feet per child in classroom and 75 sq. feet per child outdoors				
2. Pipes & radiators are inaccessible to children or covered to prevent contact				
3. Electrical cords are out of children's reach and kept out of doorways & traffic paths & not under carpets or rugs				
4. Unused electrical outlets are covered by outlet caps				
5. Medicine, in its original container, is kept in a locked place where children are unable to see or reach. (Unlocked if an emergency medication)				
6. Windows screens stay in place when pushed. Are windows & glass doors are constructed, adapted, or adjusted to prevent injury to children.				
7. Trash is in appropriate covered containers & is emptied & cleaned daily (exception - trash containers at the art table containing only paper)				
8. There are no poisonous plants				
9. Walls and ceilings are free from peeling paint & cracked or falling plaster.				
10. Floors are kept clean and in good repair				
11. No animals may be kept as pets				
12. Rooms are well lit				
13. Cleaning schedule is posted				
14. Indoor and outdoor spaces are kept clean				
15. Are children prevented from getting into unsafe and unsupervised areas? (ex. Exposed to vehicular traffic)				
16. Adequate staff is available to supervise children with the appropriate staff to child ratio (1:10)				
17. Hallways and stairs are free of clutter				
18. Hallways and stairs are well lit				
19. Hand railings are at child height and stable				
20. Stairway gates are in place when appropriate				
21. Doorways to unsupervised or unsafe areas are always locked unless this prevents emergency evacuation. These exits are equipped with a buzzer or bell.				
22. Flammable materials and equipment are not stored near furnace or hot water heaters				
23. All items not intended for children stored out of site/reach of children (staff/ volunteer personal belongings, etc).				

24. Pesticides are applied only by a certified pest control operator & when children are not present. When did the children return to the center after spraying? ____				
25. Stable step stools are available when needed				
26. Electrical appliances are not in bathrooms				
27. Are areas for diapering & toileting separate from areas for cooking, eating, & children's activities?				
28. Does the program maintain a smoke-free environment on center & home base grounds?				
29. Has the center / home base been tested for lead?				
30. Does the staff follow hand washing procedures?

1. Toys and play equipment are checked often for sharp edges and small parts				
2. Lead free paints are used on painted toys				
3. Balloons are to be used only under adult supervision				
4. Riding toys are stable and well balanced				
5. Outdoor play equipment & surface is checked daily to meet health & safety requirements.				
6. Toys are put away when not in use				
7. Art materials are labeled as non-toxic				
8. Art materials are stored in their original containers				
9. Teaching aids (projectors, etc) are put away when not in use				
10. Projectile toys (pop guns, darts) are not used				
11. Evidence that toys & classroom materials are cleaned according to the schedule

1. All staff understands their roles & responsibilities in case of emergency / accident including appropriate paperwork. (accident report and follow-up)				
2. There are staff present who are knowledgeable in first-aid and CPR (Teachers, Teacher Assistants, Bus Drivers, Home Visitors and Home Visitor Assistants)				
3. First aid kits & fanny packs are checked regularly including buses & kept within easy reach.				
4. First aid kits include only items on the first aid supply list				

5. Body fluid clean-up kits including nonporous gloves are available and easily accessible				
6. First aid kits and fanny packs contain current first aid instructions, including the bus				
7. Staff instruct and practice with the children, “stop, drop, and roll” procedure				
8. First aid fanny paks and emergency cards are easily accessible and used when outdoors or on field trips				
9. Each site has Exclusions from the Child Care Setting
